#### Surface Preparation

All surfaces must be cured, firm, dry and cleaned free of loose paint, dust, dirt, oil, grease, wax, chalk, rust, mildew or any other contamination or condition that would adversely affect the performance of the coating. Sand or abrade all glossy, dense, or glazed surfaces to be coated. See WARNING for existing lead paint under *Precautions.* 

#### Application

Brush	Roller	Spray
Synthetic Bristle	½ in – 1 in Nap	Airless; .019021 Tip - Stainless Steel, PVC, or Non-Reactive Material recommended for all surfaces that come in contact with coating.

Do not apply when material, air, and/or surface temperature is below 60°F or above 100°F. Do not apply when relative humidity exceeds 85% or less than two hours before any expected precipitation. Be aware that painting under humid conditions will negatively affect dry time. Store at room temperature and keep from freezing.

Stir material thoroughly before and during each use. Maintain a wet edge to avoid lap marks. Always apply a small test area of the coating system prior to full application to ensure the surface preparation, weather conditions, equipment, and coatings are suitable and working properly.

New asphalt and concrete should be allowed to cure for a minimum of 30 days before the application of paint. Any curing compounds used on new concrete must be mechanically abraded off prior to striping. When striping on freshly sealed surfaces use caution as some sealers can affect the curing and adhesion of traffic paint. If application is over fresh asphalt, the first coat should be no more than 7 wet mils. If applying two coats or over striping lines with the fire lane allow the first coat to dry before applying the second coat.

# Thinning

Apply at can consistency. If thinning is necessary to maintain workability, do not exceed one-half pint of water per gallon.
